# 16 Ave /Hwy 99 Interchange Scheduled for Fall 2014



16th Ave Interchange

The City of Surrey, the Province and TransLink have agreed to fund the design work for an interchange at 16th Avenue and Highway 99 have been greeted as very good news for Surrey as well as the whole of the south Fraser region, with the interchange project to be open by Fall 2014.

We have been lobbying, along with the Lower Mainland Chambers Transportation Panel, to develop an upgraded direct route across the southern part of the region to link Highway 99 with the Abbotsford International Airport. The route will also dramatically improve access to the Aldergrove/ Lynden and Surrey Border Crossings, and improve truck movements across the region servicing the Campbell Heights industrial area in Surrey's southeast corner.

The SBOT has been concerned for a number of years that the new developments in South Surrey,

particularly Grandview, have no appropriate access for travelers northbound from the border beyond 8th Avenue until reaching King George Blvd, which is too far to the north. The new interchange will dramatically change that.

As projections place another million people in the Lower Mainland in the next 30 years, with much of it in the South Fraser region, development of the Highway 99 interchange 16th

Avenue is crucial in development of that corridor.

The Lower Mainland Chambers' Transportation Panel was established by the Surrey Board of Trade and the Vancouver Board of Trade in 1997 to address common areas of interest in transportation among Lower Mainland's Chambers of Commerce. Now, the member Chambers and Boards of Trade encompass Chilliwack to Squamish.

# British Columbia moves back to the PST

B.C. will move from the HST system to a new PST regime April 1, 2013. As such, all businesses currently registered for GST/HST that transact in B.C. will be impacted by this change. You should note that the federal government has released transitional rules on how the HST will be transitioned out of B.C. while the B.C. government simultaneously released its new PST legislation. Some of the highlights of these new sets of

- 1. Effective April 1, 2013, the HST rate of 12% will no longer apply on the taxable supply of property or services made in or imported into B.C. Instead the GST rate of 5% will apply. The new PST will apply only to specific properties or services taxable under the PST
- 2. General transitional rules will be implemented so that the HST rate at 12% will apply if tax is paid or payable before April 1, 2013. GST at 5% (and PST where applicable) will generally apply on or after April 1, 2013. For these purposes, the tax is generally considered payable when an invoice is issued or when it is required to be paid pursuant to an agreement in

- 3. Special transitional rules will apply to taxable supplies on real property such as new homes.
- 4. PST will be 7% on retail purchases of most tangible personal property and related services. In addition, PST will apply to legal services, software and telecommunication services.
- 5. Businesses purchasing goods for resale will no longer be required to pay the PST.
- 6. Many of the old PST exemptions will be reinstated including, exemptions for most services, bicycles, books, newspapers and magazines, children's clothing, basic groceries (including prepared foods such as restaurant meals), dietary supplements and non-alcoholic beverages.
- 7. The new PST administration will be simplified to include on-line access for businesses, a change of filing due-dates to match the GST system and registration using the federal business number.

# Focus on Government, Advocacy, Economy and Community

The Surrey Board of Trade (SBOT) was well represented at the Annual General Meeting of the Canadian Chamber of Commerce in Hamilton this past September, where we received nation-wide support on two policy resolutions, which will be brought forward to the federal government for consideration.

The first successful resolution dealt with cross border shopping and the negative effects of the new duty exemption limits for Canadian retailers on the U.S. border. In part, the resolution is asking the federal government to eliminate outdated tariffs on finished products entering Canada, and ensures Canadian border officials enforce all tax exemption limits for all travelers returning to Canada.

The second resolution to receive support dealt with Styrofoam Recycling Policy, and further, asks the federal government to promote the domestic reuse and remanufacture of waste expanded polystyrene (EPS).

As a delegate representing Surrey I couldn't be more proud of our SBOT for

not only having the outstanding reputation as a business leader locally and provincially, but on a national front as well.

And speaking of cross border shopping, did you know that one million British Columbians are employed in small businesses in this province, and further, that "small business" forms 98 per cent of all businesses in BC?

Small Business Week is celebrated during the month of October every year but our local small businesses should be celebrated throughout the year by supporting local business and encouraging our clients and customers to do the same.

Shopping across the border regularly can jeopardize the businesses and the jobs in our communities that come with it, held by our friends and family, not to mention pay the taxes which support our government services.

And it is interesting to point out, despite the global economic downturn between 2009 and 2012, jobs generated by small business in BC actually climbed by 1.3 per

# SBOT Hosts Second Leadership Surrey Dialogue on Business and Homelessness



On October 12th, the SBOT hosted the second Business and Homelessness Dialogue focused on economic impact and opportunities for Surrey businesses to make a difference.

I announced again that in July, the SBOT released our Poverty Reduction Policy. Often the business voice is missing from the homeless and poverty reduction conversation. We took a leadership position and believe that poverty reduction is integral to our economic future. We are the first business organization in Canada to ask the provincial and federal governments to implement a 'National Poverty Reduction Strategy' with goals, objectives and target dates to reduce/eliminate poverty. Our ask is to include an 'Affordable Housing Strategy' and specifically address a 'National Child Care Program' to enable parents to work and contribute to the economic wellbeing of their families, communities and country. The SBOT wants solutions to lift people out of poverty rather than to make living in poverty more manageable.

The event attendees in three working groups discussed how business can be a part of the equation. The results were:

Question # 1: Do you agree with the recent Angus Reid Public Opinion Poll that resulted in a number of key findings indicating that business has a significant role in helping to solve this issue and can you identify specific actions that can be

taken in Surrey?

- Utilize business influence to affect change at all levels of government

# **Looking Past November 6**

on't underestimate the potential of the \$15 trillion American economy. This was a key message emerging from the 2012 Surrey Regional Economic Summit, held at the Sheraton Vancouver Guilford Hotel on October 4. I was privileged to moderate a panel discussion with Christina Romer – formerly the chair of President Obama's Council of Economic Advisors – and Wall Street Journal editorial writer Stephen Moore. While they disagreed on several issues, they shared a conviction that the United States' best days lie ahead of it.

Certainly the most recent employment numbers sound a mildly encouraging note. In September, the US unemployment rate fell below 8% for the first time since January 2009. Private sector payrolls rose for the 31st consecutive month. In fact, American companies have added 4 million jobs in the past 30 months. These private sector employment gains have been partly offset by shrinking public sector payrolls, as many cash-strapped American states and municipalities have pared staff. But public sector employment is no longer dropping.

The long-troubled US housing sector is also turning around. After peaking at more than 2 million housing starts in 2004 and 2005, residential construction activity shriveled during 2007-2009, with annual starts falling as low as 450,000 at the nadir of the epic American real estate meltdown. Housing starts have been slowly increasing since then and look set to approach 900,000 in 2013. After unprecedented declines, home



prices are now stabilizing in the regions that were at the heart of the housing downturn - Arizona, Nevada, California and Florida. This is welcome news for BC lumber producers, whose exports stateside have already started to rebound as the American housing market improves. Of interest, the pace of household formation in the United States has been running far behind historical trends for the past five years. With a steadily growing US population, this can't continue indefinitely. As household formation picks up, the conditions will be laid for stronger residential investment, higher lumber prices, and increased BC lumber shipments to the vital US market.

A final piece of positive news comes from corporate America. Outside of the financial sector, business balance sheets are generally in good shape, and most large US companies have ample cash reserves on hand to support future hiring and investment. Against the backdrop of a struggling global economy and an uncertain policy and political environment at home, many US businesses have been reluctant to spend. But this caution should ease somewhat over the course of the next 12-18 months.

None of this is to minimize the economic and policy challenges confronting America, nor to overlook the reality that the broader international economy has been losing momentum over much of 2012. The Eurozone is in recession, Japan remains weak, and many emerging economies – including China and India – are marking down

their near-term growth projections. Although the United States is a far more "closed" economy than is Canada, meaning that it is less affected by what happens in external markets,



Recent published forecasts suggest the US economy will grow by a tepid 2% next year, similar to what's expected for 2012. In my view there's some chance of an economic boost once the national elections are out of the way next month. And looking past 2013, I am optimistic that the American economy is positioned for several years of solid expansion, as the painful after-effects of the 2008-09 downturn and the collapse of the preceding credit boom gradually dissipate. As the healing process continues, US real GDP growth should climb to 3% plus in both 2014 and 2015.

# TAX BITES


The Expert Panel on British Columbia's Business Tax Competitiveness recently submitted its final report to the BC Finance Minister. Their mandate was to consider how to enhance BC's tax competitiveness in the context of the 2011 referendum decision to re-implement the Provincial Sales Tax (PST) effective April 1, 2013.

The return to PST will make BC businesses "face the highest effective tax rate on new investments among the provinces in 2013", hence significantly increasing the cost of capital investment.

In a way, BC is currently experiencing the silence before the storm of PST hitting the bottom line. Before that happens, business owners will want to be aware of any meaningful proposals that may provide some relief. The report, as presented by the panel, has the potential to make some difference.

Most of the panel's 38 recommendations relate to PST and municipal taxes and the key recommendation, Recommendation 1, is that BC introduce a refundable investment tax credit (ITC) equal to the PST paid on all acquisitions of machinery and equipment (including computers and software). Buildings and structures with a capital cost allowance rate of 5% or less would not be eligible. The ITC would be claimed on businesses' income

tax returns and would be spread over two years in equal amounts. Other



- The BC government should appoint a task force to explore and develop a Business Transfer Tax, a form of valueadded tax calculated on the basis of the total sales and purchases reported by a
- Beginning in 2014, a surcharge should be introduced on provincial mining and oil and natural gas revenues equal to the estimated value of the ITC that these sectors are expected to receive under Recommendation 1.
- Remove the sunset clause for the BC scientific research and experimental development (SR&ED) credit, making it an ongoing feature of BC's taxation system.
- Increase BC's corporate income tax rates by 0.5%, beginning April 1, 2014.

The BC Finance Minister has asked the Select Standing Committee on Finance and Government Services to include the panel's report in the committee's 2013 budget consultation process this fall.





# **\$1.75-million** employer fund to attract and integrate skilled immigrants

The Immigrant Employment Council of BC (IEC-BC) will design, implement and manage a new initiative that will support BC employers, industry and business associations in developing approaches and resources that address challenges in hiring, integrating and retaining new skilled immigrants.

"This is an exciting employer-focused initiative that will result in innovative and practical approaches that employers have told us they need to support the hiring and retention of skilled immigrants," said Bob Elton, Chair, Immigrant Employment Council of BC. "Employers know we are entering an era of unparalleled global talent scarcity and competition and want to tap into skilled immigrant talent. The projects and resources funded by this initiative are intended to help employers develop new ways to meet their labour needs today and in the future."

Supported by funding through the Province of BC, Ministry of Jobs, Tourism and Skills Training, IEC-BC will engage key employer stakeholder groups in the implementation of the Fund, targeting small and medium sized enterprises, business associations such as Chambers of Commerce and Boards of Trade, and Sectoral Associations.



# **ER Tower: Countdown To** Completion

In less than a year the Surrey Memorial Hospital's new Emergency Department, which will occupy the ground floor of the Critical Care Tower, will open. Equal to the size of a football field, the new ER will dwarf the old one – BC's busiest with close to 100,000 patient visits annually.

Among the most significant changes will be a children's ER, with a separate entrance to help reduce the anxiety

of the children and their families. Staffed by pediatric specialists it will include the latest technology for the more than 18,000 young patients annually.

The new ER will have special zones to care for the acutely ill, those with minor injuries, and mental health and substance use patients.

The Emergency Department is only one part of the \$512 million expansion and redevelopment taking place. When complete in 2014, the Critical Care Tower will include a new 48-bed Neonatal Intensive Care Unit for premature and sick newborns. The number of critical care beds for adults will more than double with the expanded Intensive Care Unit and a new High Acuity



A new neurology unit on the top floor will have a strong emphasis on stroke care to help patients recover from the number one cause of acquired long-term disability in adults. A new lab will process millions of

Finally, Surrey Memorial will increase its responsibilities as a UBC-affiliated teaching hospital, and will help develop the doctors of tomorrow by training medical residents

# When the Chips Are Up - Foiling the bad guys!

RFID technology (radio frequency identification) allows us to save seconds of time by waving our credit card by the scanning reader on the counter or at the gas pump without swiping or inserting it into the reader.

This technology is now in our Enhanced Driver's Licences, Nexus cards, debit cards, credit cards and Canadian passports are next. It works by having

the electronic scanner send a signal, which is received by an antenna embedded into the card, which is connected to the card's RFID chip, thus activating it. The RFID chip in these cards emits all of the information, including the account number that is needed to complete a transaction.

The idea is to have this contactless, smartcard system replace the black magnetic stripe found on the back of the card. But to make that work, every country needs to adopt it so your pay cards are effective when you travel. That is the convenience part.

The continuous need for knowledge and protection part says that these cards can be read without even taking them out of your wallet. Some cards can even be read

up to 75 feet away. The banks and various bodies that supply the cards utilizing this technology will all tell you that the system is safe, secure and well encrypted. But to be on the safe side, these cards should be kept in a special foil-lined protective sleeve that shields the chip, thus protecting the information contained on it.

By the way, I should mention that in the case of most Canadian bank debit cards. you can go to your bank branch and have the "system" turned off. This only applies to debit cards.

# **Tips For Smooth Importing- From Pacific Customs Brokers**

- Research your commodity before you import. Is it a regulated commodity? Some items are prohibited from entry into Canada.
- Customs clearance is not instantaneous. A customs broker has
  to recreate your Canada Customs Invoice (CCI) line by line
  electronically for the Canada Border Services Agency (CBSA)
  and other government departments and has to be reviewed by
  them.
- 3. You should use one customs broker for all modes of transportation and all ports of entry.
- 4. Examinations can be performed by any of the departments involved in importation AND even if previously accepted by Customs.
- 5. The Administrative Monetary Penalty System (AMPS) can be issued if any information provided is not in compliance with Customs regulations or found to be untrue.
- 6. Free samples and giveaways still require the same information for Customs clearance as if they were purchased, including an accurate commercial value. Duties and taxes are still applicable.
- 7. Government forms can be confusing to complete. Save yourself time and read the instruction sheet before filling the form to ensure that it is completed correctly.
- 8. Some commodities require additional documentation and certification in order to clear CBSA and other government departments. Without the required documents, commodities entry may be refused.

# New tariff relief for Canadian manufacturers

The Honourable Jim Flaherty, Minister of Finance announced new tariff relief for Canadian manufacturers to foster jobs and growth. This relief is expected to save Canadian businesses about \$1.7 million annually.

"This initiative builds on our Government's commitment to make Canada a tariff-free zone for industrial manufacturers—the first country in the G-20 to do so," said Minister Flaherty. "This tariff relief will lower costs for Canadian businesses, enhancing their competitiveness in domestic and international markets, and fostering jobs and growth."

The Government is eliminating customs duties on certain products in the following categories:

- Palm oil flakes for use in the manufacture of food products;
- Trays designed to hold discs for use in the manufacture of CD or DVD cases;
- Fabric shells for use in the manufacture of bed linens such as duvets, comforters, featherbeds, cushions and pillows;
  - Crossing pieces for guard rails; and
- Certain chassis and motors for use in the manufacture of ambulances.
